AGREEMENTS REACHED and ACTION ITEMS

AGREEMENTS REACHED:

1. IFAST21 will be held January 29-30, 2003 in Sao Paulo, Brasil
2. IFAST22 will be held May 7-8, 2003 in Los Angeles, CA, USA

ACTION ITEMS:

1. An effort will be made for IFAST to have a presentation at the CTIA Show on IRM exhaustion and IMSI implementation
2. Zaeem Hosain will revise and send an advanced copy of the IRG to the Management Team.
3. Zaeem Hosain will send a copy of the revised IRG to the IFAST list serve.
4. Megan Hayes will coordinate the next issue of the newsletter.

INCOMPLETE ACTION ITEMS FROM IFAST19:

1. Bernardo Martinez will draft an announcement for the IFAST web site describing the problem of FCC 02-120 and its impact on IFAST. The announcement should indicate that IFAST discourages other telecommunications authorities from implementing a similar solution.
2. Fred Gaechter will contact Watson Zan to request contact with CWTC, CRTC and CWTA to inform them of the concerns regarding a potential Canadian implementation of rules regarding non-initialized callback similar to those contained in FCC 02-120.
3. IFAST will correspond with TR45 and the UIMID Administrator to suggest that the full database information with regard to UIMIDs be made publicly available. (David Crowe)
4. Fred Gaechter will correspond with Gustaf Van Ditzhuijzen of the GGRF to invite him to explore the IFAST web site, especially the International Roaming Guide (IRG). In addition, a request will be made to determine the most effective way for the IFAST and the GGRF to work together.
5. Fred Gaechter will contact the CDG to attempt to coordinate a permanent liaison. (send to Terry Yen).
6. A preliminary investigation letter will be put together to determine whether service providers would be willing to share ANSI-41 implementation information in a database to make it easier to determine levels of IS-41 compliance for roaming agreements. (David Crowe)
7. Phyllis Anderson and Troy Albina will request information from international gateway operators on IMSI implementation issues and report back to IFAST on their findings.
8. David Crowe will send a letter regarding IMSI Implementation problems to GGRF, GSM-NA and GSM Europe with copies going to 3GPP2, 3G Americas, CDG, and TR46. The letter should request a response by December 1, 2002.
9. Zaeem Hosain will update the IRG Release 1.2 and forward it to the Implementation Awareness Project email list for their review.
10. Zaeem Hosain will contact Dave Grootwassink and Watson Zan for their input into the IRG.

INCOMPLETE ACTION ITEMS FROM IFAST18:

1. There will be a liaison sent to TSG-N regarding the Uniformity Survey and Uniform Dialing Plan to determine whether there is some work that IFAST and TSG-N could collaborate on. (Doug Rollender, David Crowe, Fred Gaechter)
2. The Uniformity Survey results will be compiled for presentation at the IFAST19 meeting. (Fred Gaechter and Megan Hayes)
3. Dave Grootwassink will add a section to the IRG on Pre-Paid services.
4. A liaison will be written to TR45.2 and TR46.3 encouraging standards work on the interworking of CAMEL and WIN in light of pre-paid services. (David Crowe, Dave Grootwassink, Ravi Iyer and Doug Rollender)
5. Megan Hayes will remove the Roaming Agreement Model from the IRG and place a reference to the CTIA Model in its place.
6. Members will review the IMSI text in the IRG and suggest any modifications necessary. Should modifications be made, IFAST could draft a statement to the IS-41 community.
7. Fred Gaechter will discuss the idea of a regional reference directory with the regional members of the IFAST Management Team to determine whether there is interest in such a directory.
8. Fred Gaechter will contact Asian IFAST members to determine whether any would be interested in Management Team participation. (Talk with Terry Yen)
